To receive royalties as a master rights owner, you need to declare all the sound recordings and music videos you own to Soproq. This can be done online through our web portal **Octave**.

You can make a declaration for products containing sound recordings or for a music video. Before starting a declaration, make sure you have all the required information. The following table indicates the mandatory, optional and not required information for each type of declaration. Once completed, make sure you submit your declaration by clicking the "Submit your declaration" button.
